

### Celebrating 38 Years of Service to Disadvantaged Children

Street Children International (SCI) has successfully completed 38 years of serving destitute children. This success would not have been possible without the consistent, unwavering support of our members who are determined to make a difference in the lives of disadvantaged children. SCI members hold meetings in their own homes and volunteer many hours of their time so that the funds can go directly to meet the needs of the children whenever possible. Out of every dollar collected, 99 cents are used for the children. Our administrative costs are scrutinized and pared down to basic operational needs - printing costs, mailing costs, etc. Our individual homes serve as our offices.

During the past 38 years, SCI has served hundreds of children who have learned the value of education in achieving their potential. The children in the SCI-supported schools have grown up with a strong belief that living a good life is possible if you believe in yourself. Many of these children have been able to help their family and friends to strive for a better life.

Some of our children have gone on for higher studies in local colleges, technical institutes, and even to medical college. We are hoping this positive outcome would inspire more people to join us as members and bring in their own suggestions and referrals for SCI assistance. Active participation of members can have an impact in the lives of hundreds of destitute girls and boys living in unimaginable hardship. By sparing a few dollars of our money, donors have the satisfaction of knowing that we were able to reduce some suffering and carving a path towards a life of dignity. It has been quite an adventure to inspire the children to dream big! We invite you to share our experience and be a part of this adventure.

SCI's annual fundraising program is a key event where we collect donations to support the continued effort in transforming the lives of many poor children and offer a new world of opportunities to the most underprivileged among us.






